Invitation to submit Quotation for printing of "SILVAN WAVES 2023" – SILVAN SOUVENIR

Sealed quotations along with an Earnest Money Deposit (EMD) equal to 5% of the quoted value are invited from registered Printers for printing and binding of "SILVAN WAVE 2023" - SILVAN SOUVENIR as per following specification:

Expected total number of pages after final proofreading – Approximately 140 (136 inner pages + 4 cover pages) - 70 pages (approx..) with photo or photo with text. Text in English and Hindi.

Paper size – 210mm x 280mm, Multi-colour

Paper quality –White paper, 90 gsm, glossy art paper

Photos – 4 colour

Cover – 4 colour printed on 250 gsm art board paper

Lamination – one side cover gloss

Finishing – glue binding

Copies – Total expenditure and Rates (inclusive of all taxes) should be quoted for both 300 copies and 500 copies

The printer will have to submit a design first. On approval of the design, first proof will be submitted. Then the final proof, incorporating required corrections, will be submitted. On its approval printing work will be done. The Souvenir duly bound will have to be supplied within 15 days from the date of order. Payment will be made by SILVAN after all copies are supplied in time in accordance with the quality mentioned.

Quotations must be accompanied by an **Earnest Money Deposit (EMD) equal to 5% of the quoted amount. It should be in the form of Bank Draft in the name of "Society of Illustrious Veterans and Naturalists" payable at Ranchi.** Quotations without EMD of required amount will not be considered. If the quotation is not accepted, EMD will be returned. If the quotation is accepted, EMD will be retained till all copies are supplied in time in accordance with the quality mentioned in the order. If the supply is not satisfactory, the EMD will be forfeited.

Conditional Quotations will be summarily rejected. No conditions or fresh demands after the order for printing is issued will be accepted, and the EMD will be forfeited in such case.
